1. THE WARRANTY

Dynacom products are built under rigid documented procedures. We are confident in their uniformity and conformity to the highest industry standards. Dynacom warrants all of our TIA, 568-A compliant Premises Network Wiring Products for 25 years. The products can be used as stand-alone components or an integral part of a high speed Category 5 Datacom cabling "link", as specified in TIA/EIA TSB-67. The Dynacom warranty is to the end user only.

2. DOCUMENTATION & ACTIVATION

To activate the warranty an "Application for Warranty" must be completed. The installer of record must complete documentation form. The following information is required:

- ▲ The user's company, contact name and the site location
- ▲ Dynacom products by part number and quantity
- ▲ The application and system *activation or cut-over date.
- ▲ The "Application for Warranty" form must be completed, in full and returned to Dynacom within 15 days of system power up.

*The warranty becomes effective upon Dynacom's receipt of the "Application for Warranty" form submitted by the installer of record. By registering the system and or components with Dynacom, the 25-year warranty clock is started. The warranty and Dynacom's obligation expires on the anniversary of the "activation" twenty five years, to the date in the future.

3. CERTIFICATION

Dynacom will register, certify and validate the installation location, application and use date of Dynacom products. Within 15 days the Dynacom will issue a "Certificate of Warranty" to the end user or other contact(s) at the address(s) listed on the "Application for Warranty". Applications for Warranty are available from Dynacom or authorized agents.

4. TERMS & CONDITIONS

Dynacom products are fully warranted under our liberal evaluation policies. We rely purely on visual inspection by Dynacom authorized personnel. Obvious misuse, damage due to miss-handling or other gross or non-industry accepted installation methods or uses would be determined, by an on the spot evaluation by Dynacom or authorized supplier (Distributor).

The warranty provided herein shall be void and unenforceable to the extent that the product (s) have:

- ▲ Been subject to: abuse, neglect, misuse, vandalism, improper repackaging, or damage by accident; fire, flood, wind, earthquake or any other act of God.
- ▲ Been used in non-compliant or improper: application, repair, alteration, system design, installation or construction.

The warranties contained herein are in lieu of all other warranties, expressed or implied, including, but not limited to, any implied warranty of merchantability or fitness for a particular purpose. In no case shall Dynacom be liable for any incident, special or consequential damage. This limited warranty is non-transferable from the original ownership or location.
